
WADA also provided BADC with webinars for all athlete support personnel, Federations and athletes on a monthly basis, which was shared with each respective party.

Major steps in ensuring we remain compliant with the World Anti-Doping Standards and Guidelines was the completion and updated of the following:


- Creation and implementation of the BADC Anti-Doping Rules, as per WADA standards

TESTING ACTIVITIES


In 2021, BADC's testing program faced significant limitations due to the ongoing COVID-19 pandemic. Only a total of 17 tests were completed throughout the year. This reduced number of tests was a direct result of many sports organizations suspending or significantly altering their training and competition schedules in response to the pandemic. Despite these challenges, the program continued to prioritize the enforcement of anti-doping regulations to the best of its ability under the circumstances.





FINANCIAL STATEMENT OVERVIEW

This report provides an insight into our financial performance, highlighting our ability to adapt and maintain fiscal resilience amidst the challenges posed by the COVID-19 pandemic.

Budgetary Changes:

In 2021, The Bahamas Anti-Doping Commission experienced a slight increase in its budget allocation from the Ministry of Sports. Our budget grew from \$298,000 in the previous year to \$333,000. While this increase was modest, it enabled us to continue our vital work in preserving the integrity of sports in The Bahamas and maintain salaries.

Testing Income:

The year 2021 marked a slight improvement in our testing income compared to the previous year. In 2020, our testing income was non-existent due to the complete shutdown of sports activities amid the pandemic. However, in 2021, we managed to generate a little over \$3,000 in testing income, signifying a modest but noteworthy recovery.

Expense Management:

The Bahamas Anti-Doping Commission demonstrated prudence in expense management during 2021. Total expenses for the year amounted to \$179,000. Several factors contributed to this, including reduced stipends for board members and consultants, decreased operational costs, and savings in utilities due to staff working remotely. Importantly, we maintained staff salaries and employee benefits at their previous levels.

Operational Testing and Virtual Education:

It is essential to note that operational testing was significantly affected in 2021 due to the ongoing pandemic. Sports activities and competitions were limited or postponed for most of the year, leading to a reduced need for anti-doping testing. Consequently, major efforts were redirected towards virtual education and awareness programs, emphasizing our commitment to educating athletes and stakeholders on anti-doping regulations.

Conclusion:

In conclusion, The Bahamas Anti-Doping Commission navigated the challenges of 2021 with resilience and adaptability. Despite the limitations imposed by the pandemic on operational testing, we managed to maintain our financial stability and even recorded a modest increase in budgetary allocation. We are grateful for the continued support of our stakeholders and remain steadfast in our mission to uphold the integrity of sports in The Bahamas.
